### **CDN Quality Steering Group Constitution August 2015 (updated from Scotland's Colleges' Quality Community of Practice 2011)**

#### **Purpose of the Quality Steering Group:**

Provide a forum for staff operating in colleges across Scotland to meet on a formal and informal basis as professionals to exchange information, to network, to provide a specialist perspective and to undertake professional debate on a range of issues which impact on the themes of quality;

Encourage, devise and support continuing professional development activity for Members;

Act as a consultative body on agreed topics and provide formal responses on behalf of the colleges across Scotland to sector agencies when requested;

Establish links and strong working relationships with other *CDN Steering Groups* with an aim of sharing information and expertise and facilitating opportunities for joint activity;

Foster development of practice and greater awareness of the college sector through the augmentation of links with stakeholders, professional bodies and individuals in Scotland and across the UK and internationally, as appropriate.

#### **Membership of the Quality Steering Group:**

Membership of the Quality Steering Group is open to any member of staff working within one of Scotland's colleges or related stakeholder organisations in a cross college quality management role;

Should vacancies become available on the steering group the current membership will consider the case for a new member joining on an individual basis;

Membership of the Quality Steering Group may be extended to individuals or other stakeholder organisations at the discretion of the steering group;

The Quality Steering Group will have a chair and vice-chair elected by the members, with the vice-chair being the chair elect. The posts will be held for a minimum period of one year and a maximum period of four years and incumbent postholders are eligible for re-election;

The standard procedure for the election of the chair, vice-chair and members will be as follows:

- The Quality Steering Group will request nominations for steering group members from each college region (Appendix 1 shows the college regions at the time of this review)
- Nominations will be restricted to one nomination per region
- The chair and vice-chair will be elected from the steering group members who will nominate and vote for each of these posts
- In addition to the above there will be 5 non-voting memberships available for stakeholder organisations or individuals not operating in a college in Scotland
- Members who do not attend three consecutive steering group meetings without valid reason will have their membership status re-considered by the steering group

## **Operation of the Quality Steering Group:**

- The Quality Steering Group steering group, along with the CDN appointed lead, will decide on the annual programme of events. It is expected that the Quality Steering Group will work with any Quality Steering Group sponsors to accommodate their requests;
- Any requests for changes or amendments to this constitution will be routed through the steering group and considered at an appropriate time. This constitution will be formally reviewed and approved by the steering group every four years;
- Changes to the constitution will not render existing membership invalid but will take effect through natural turnover of future membership;
- The steering group will aim to meet at least three times per year and hold one annual Conference;
- The chair, or appointed member, of the Quality Steering Group will represent the steering group on external committees/groups to enhance working relationships which contribute to the development of a quality culture throughout the college sector.
