5.2 Agenda Item: 5 | Paper No: CDN/270324/2 | Lead: MH (CEO's Report)

MH provided a brief overview of the CEO's Report which the Board noted. MH provided the Board with an update on discussions with SFC regarding CDN's funding and the review which SFC will undertake. The Board were advised that CDN will take out another year's membership of the World Federation of Colleges and Polytechnics in order to maximise the opportunities to share international best-practice with the sector. The Board discussed the report.

6. Items for Discussion/Approval

6.1 Agenda Item: 6 | Paper No: CDN/270324/3 | Lead: VU/GH (Strategic Dashboard)

VU opened a discussion on the Strategic Dashboard by highlighting the work achieved by CDN during a period of re-structure and in particular mentioned: Curriculum ideation work with colleges; Thinking creatively to reimagine the curriculum has been received positively by the sector and is a potential area of growth for CDN. Our work relating to Equality Diversity and Inclusion, to ensure it is embedded throughout the curriculum, is an area of work where impact is becoming more visible. GH provided an overview of the Governance pilots which have taken place relating to Governing in High Stakes. Feedback has been positive, and these courses will be repackaged and offered to the sector as part of our revised College Governance Programme. GH highlighted the pilot, which is currently underway at Ayrshire College, which is another area of work, which if proven worthwhile, will be offered to the sector. A discussion took place in relation to how best the level of engagement with colleges and sectoral agencies can be captured in the Strategic Dashboard. The Dashboard will be further developed and provided to the Board, as agreed, at the September 2024 meeting.
